Instructions: Pull 30-40 mane or tail hairs with roots attached. Only one sample per horse is required to run multiple test
PLEASE PLACE HAIR IN AN ENVELOPE AND LABEL CLEARLY. (please make sure that no hairs are exposed)

PLEASE NOTE: If you select to have your horse Parent Qualified and the resulting report excludes either parent in the case of purebreds or one parent for partbreds on the registration form, your papers will be held until the correct parents are located.

The submitting owner acknowledges that the samples are submitted on the condition that all profiles derived from the samples will be incorporated into the Massey database to be solely used for the verification of the parentage of any animal at any time that is applying for registration with the New Zealand Gypsy Cob Association Inc.
